Dear Mr. President:

The Candidature of Sweden 2030

This letter is prepared in connection with the Candidature of Sweden 2030 in response to the requirements outlined in the documents captioned ‘Contractual Framework for hosting the Olympic and Paralympic Games’ dated in January 2020, and the ‘Future Host Questionnaire – Olympic Winter Games’ dated in October 2022, together with the ‘Annex Future Host Questionnaire – List of Guarantees – Targeted Dialogue’, dated in September 2022 (the “**List of Guarantees**”). Terms with capital letter used but not defined herein will have the meaning set out in the Contractual Framework Agreement.

The City of Stockholm is honoured to participate as a municipality in connection with Sweden’s Candidature for the 2030 Olympic and Paralympic Winter Games.

We offer our enthusiastic support on behalf of the City of Stockholm for the Candidature of Sweden 2030 to host the Games and are thrilled that the City of Stockholm has an opportunity to host Games events in the City of Stockholm. We are confident that the City of Stockholm will provide athletes, spectators, media, Olympic and Paralympic Family and all other Games clients with a world-class experience. The City of Stockholm stands ready to partner with the Candidature of Sweden 2030 in this endeavour.

The City of Stockholm will cooperate with all levels of government, local, regional and national, as well as with the Candidature of Sweden 2030 organizing committee to ensure the organizing committee together with other participants and stakeholder is able to deliver on its commitments and obligations within Games planning, delivery and legacy.

I hereby confirm, on behalf of and as the duly authorized representative of The City of Stockholm, as follows (to the extent permitted under Swedish mandatory law):

- **Respect of the Olympic Charter including IOC Code of Ethics (Section G5.2, items (i) and (ii) in the List of Guarantee).** We hereby guarantee and confirm (i) that the City of Stockholm will respect the Olympic Charter including the IOC Code of Ethics in all activit-

ies related to the organization of the Olympic and Paralympic Winter Games 2030, in particular through an acknowledgement of the prohibition of any form of discrimination with regard to a country or a person on grounds of race, colour, sex, sexual orientation, language, religion, political or other opinion, national or social origin, property, birth or other status; and (ii) the absence of any legal obstacle to the organization of the Games in accordance with the Olympic Host Contract.

- **World Anti-Doping Code (Section G5.2 (iii) in the List of Guarantees).** The City of Stockholm hereby guarantees and confirms – to the extent applicable or relevant for the City of Stockholm – that all necessary measures will be taken to ensure the following; (i) the National Anti-Doping Organization is compliant with the World Anti-Doping Code and possesses the resources, experience and expertise to deliver doping control programmes nationally and internationally and commits to supporting the OCOG with advice, personnel training and resources as prescribed by the World Anti-Doping Agency (“WADA”); (ii) our commitment to cooperate and sharing of information between the sports authorities and the public authorities (police, customs) in relation to the fight against doping and to implement the commitments of Sweden under the UNESCO Convention against Doping in Sport and the World Anti-Doping Code; and (iii) the respect of all other arrangements specified by WADA and the IOC in relation to the antidoping regime leading into and during the Games.
- **UN Guiding Principles on Business and Human Rights (Section G5.2 (iv) in the List of Guarantees).** The City of Stockholm hereby guarantees and confirms – to the extent applicable or relevant for The City of Stockholm – that necessary measures will be taken so that, in all activities related to the organisation of the Games, human rights are protected and respected. Further, any violation of human rights will be remedied in a manner consistent with international agreements, laws and regulations applicable in Sweden and in a manner consistent with all internationally recognised human rights standards and principles, including the United Nations Guiding Principles on Business and Human Rights, applicable in Sweden.
- **Media Freedom (Section G5.2 (v) in the List of Guarantees).** The City of Stockholm hereby guarantees and confirms – to the extent applicable or relevant for the City of Stockholm – the absence of restrictions on the freedom of the media to provide independent news coverage of the Games and related events, on the editorial independence of the material broadcasted or published by the media and on the right of participants, media, other accredited persons and spectators to access and use the internet in and around all Key Olympic Venues, transport hubs and other sites used in relation to the Games.
- **International Standards on anti-corruption and other matters (Section G5.2 (vi) in the List of Guarantees).** The City of Stockholm hereby guarantees and confirms – to the extent applicable or relevant for the City of Stockholm – that necessary measures will be taken so that (i) in all activities related to the organisation of the Games, any act involving fraud or corruption is prevented or remedied, in a manner consistent with any international agreements, laws and regulations applicable in Sweden and all internationally recognised anti-corruption standards applicable in Sweden and (ii) any international agreements, laws and regulations applicable in Sweden, with regard to planning, construction, protection of the environment, health and safety, labour and working conditions and cultural heritage, will be adhered to.

- **Sport betting and manipulation of competitions (Section G5.2 (vii) in the List of Guarantees).** The City of Stockholm hereby guarantees the absence of involvement in, and no support of, any sport betting in relation to the Games and the support of the IOC in protecting the integrity of sport with regards to sport betting and manipulation of competitions in relation to the Games.
- **Cooperation and sharing of information (Section G5.2 (viii) in the List of Guarantees).** The City of Stockholm hereby commits to cooperate and share information with the IOC, as well as, where relevant, other Games stakeholders, as required in order to protect the integrity of the Games by preventing, investigating and sanctioning doping, manipulation of competitions and any other breaches of the IOC Code of Ethics or applicable laws.

We further confirm that the City of Stockholm will take the appropriate measures within its jurisdiction, in all activities related to the organization of the 2030 Olympic and Paralympic Winter Games, insofar as it relates to, is applicable to or relevant for the City of Stockholm, including but not limited to, to issue a Public Service Guarantee guaranteeing and confirming the provision of [the required] public services, together with information as to whether such services will be made available at no cost to the OCOG or whether a contribution from OCOG will apply (in compliance with the **Public Services Guarantee (Section G1.11 in the List of Guarantees)**). We will further collaborate with the Candidature of Sweden 2030 organizing committee to identify where elevated or other levels of service may be required and what the cost is to the organizing committee.

I also confirm that the Games concept and master plan of the Candidature of Sweden 2030 are in alignment with existing long-term development plans and strategies The City of Stockholm.

The City of Stockholm shares the Candidature of Sweden 2030's desire for the Games to be organized in the best possible manner and take place under the best possible conditions for the benefit of the residents of the venue cities and regions involved, the Olympic and Paralympic Athletes of the world and the Olympic and Paralympic Family and leave a sustainable legacy for the host cities, venue cities and the Olympic and Paralympic Movements.

The City of Stockholm looks forward to continuing to work with the Candidature of Sweden 2030 towards our shared objective of Sweden being selected to host the Games 2030. Bringing the Olympic and Paralympic Winter Games 2030 to Sweden for the first time is a great opportunity for us to showcase our vibrant and forward-thinking country to the world, and we stand ready with the Candidature of Sweden 2030 in this endeavour.
